LOBBY RENOVATIONS COMPLETED AT BANK OF AMERICA FINANCIAL CENTER

New Look Modernizes Landmark Vancouver Office Building

The Schlesinger Companies have completed a major lobby renovation at the Bank of America Financial Center.

The upgrades were initiated when, in September, 2007, the Schlesinger Companies acquired the balance of what had previously been a co-ownership of the property. With this acquisition, the Schlesingers wanted to modernize the look and feel of the building's lobby and common areas.

Upgrades include stone flooring, new carpeting, fresh paint, energy-efficient lighting and local artwork.

Ownership's goal was to enhance the building's appeal to current and potential tenants. Existing on-site amenities include parking and valet services, an athletic club, bank branch and Water Lily Café.
